Background

Council resolved on 24 August 2015 that:

Heritage Advisor to prepare a report detailing the potential for applying for heritage listing on both the Cenotaph and Rotunda located in Central Park detailing the benefits and potential implications of such listings.

Discussion

Council's Heritage Advisor, Ms Kate Higgins, has reviewed the proposed listings and provided the substance of this report. The War Memorial (Cenotaph) and Rotunda are considered separately.

War Memorial (Cenotaph)

The War memorial is located at the south-west corner of Central Park, Bourke. The War Memorial is comprised of a group of commemorative elements: the central column relating to WW1; the five short pillars around the column relating to WW2, the Korean War and the Vietnam War; and, the "Lest We Forget" entrance gates. The central column of the War Memorial was erected in 1920. The entrance gates following WW2, and the pillars following the end of the Vietnam War.

The Statement of Significance for the War Memorial is:

"The War Memorial is a focus for all wars this century and is use for remembrance ceremonies. It is the main War Memorial in the town of Bourke and is at the entrance to Central Park. The central Column was constructed after World War I and is devoted to that war. The five pillars have been added and include World War II, Korea and Vietnam."

The Bourke Shire Community Based Heritage Study identified the War Memorial as a place of local heritage significance which should be listed as a heritage item in the Heritage Schedule of Bourke Local Environmental Plan 2012.

Central Park Rotunda

The Rotunda in Central Park is believed to have been built around the beginning of the twentieth century. It has been used by Bourke's town bands during the twentieth century and in 2000 was the podium for speeches from Queen Elizabeth II and the NSW Premier Bob Carr on the occasion of the Queen's visit to Bourke.

The Statement of Significance for the Rotunda is:

An important focus point in the social and cultural life of the town of Bourke.

The Bourke Shire Community Based Heritage Study identified the Rotunda as a place of local heritage significance which should be listed as a heritage item in the Heritage Schedule of Bourke Local Environmental Plan 2012.

Benefits and implications of Heritage Listing

The benefits of listing the War Memorial and Rotunda as a heritage items include:

- protection for the place, as a key purpose of heritage listing is to ensure that the place is retained;
- the impact on the heritage values (including aesthetic values) of the place are considered prior to undertaking any work;
- the protection of the setting of the War Memorial and Rotunda arising from the need for development in the vicinity of the heritage item to consider the impact of the proposed development on the setting of the heritage items;
- the signalling by Council that the War Memorial is a special place and one of which the community can be proud;
- access to free heritage advice from Council's Heritage Advisor;
- access to Council's Local Heritage Assistance Fund to help pay for repair works; and
- enhancing applications to other bodies in cases where the places might be eligible for funding.

The potential implications of heritage listing include:

- the need to consider the impact of proposed works on the heritage values of the place, with the potential that some proposed works may be unacceptable;
- the need to make a development application if it is desired to make significant changes to the place; and
- the need to advise Council in writing if minor works are proposed and for Council to respond in writing prior to the works being undertaken.

It is important to note that heritage listing does not prevent changes being made to a place. Rather it seeks to ensure that changes are sympathetic.

Heritage Advisor's recommendations

Council's Heritage Advisor is of the view that both the War Memorial and Rotunda should be made a local heritage items.

Summary

Bourke Shire Council will once again be an active participant in the Asbestos Awareness month in November, Council staff through the month of November will be actively promoting the importance of Asbestos Awareness across our LGA not only households but for businesses and trades people.

Report

November is national Asbestos Awareness Month. In the lead-up to Asbestos Awareness Day (Friday 28 November 2015) all Australians especially homeowners, renovators tradies and handymen need to *Get to know Asbestos this November* by visiting asbestosawareness.com.au and take the 20 Point Asbestos Safety Check to learn how to protect themselves and families from exposure to dangerous asbestos fibres.

Asbestos could be anywhere! Under floor coverings such as carpets, linoleum and vinyl tiles, behind wall and floor tiles, in cement floors, internal and external walls, ceilings and ceiling space (insulation), eaves, garages, roofs, around hot water pipes, fences, extensions to homes, garages, outdoor toilets, backyard and farm sheds, chook sheds and even dog kennels.

Asbestos products can also be found buried beneath and around homes leftover from the original construction when it was common practice for builders and labourers to bury broken asbestos materials on building sites which can now be exposed when digging, gardening or redeveloping land.

When it comes to asbestos, Don't play Renovation Roulette! Don't cut it! Don't drill it! Don't drop it! Don't sand it! Don't saw it! Don't scrape it! Don't scrub it! Don't dismantle it! Don't tip it! Don't waterblast it! Don't demolish it! And whatever you do... Don't dump it!

Get to know Asbestos – The 20 Point Asbestos Safety Check

- 1. At least 1 in 3 Australian homes contains asbestos including brick, weatherboard, fibro and clad homes.
- 2. Asbestos was widely used in building materials before 1987 so if your home was built or renovated before 1987 it most likely contains asbestos.
- 3. If asbestos is disturbed during renovations or maintenance your health and the health of your family could be at risk.
- 4. DIY is not recommended where asbestos is present.
- 5. When renovating or working in and around homes, if in doubt assume asbestos materials are present and take every precaution.
- 6. Dealing with asbestos is important and serious, but it's not overwhelming IT IS MANAGEABLE!

- 7. If you're not sure if asbestos is in your home you can have it inspected by a licenced removalist or a licensed asbestos assessor.
- 8. Products made from asbestos cement include fibro sheeting (flat and corrugated), water, drainage and flue pipes, roofing shingles, guttering and floor and wall coverings. It could be anywhere!
- 9. If you find asbestos in your home; Don't cut it! Don't drill it! Don't drop it! Don't sand it! Don't saw it! Don't scrape it! Don't scrub it! Don't dismantle it! Don't tip it! Don't waterblast it! Don't demolish it! And whatever you do... Don't dump it!"
- 10. If left undisturbed asbestos materials in good, stable condition are unlikely to release dangerous fibres and pose a health risk. Generally, you don't need to remove the asbestos. Paint it and leave it alone but remember to check it occasionally for any signs of wear and tear.
- 11. There are legal requirements regarding asbestos management, its removal and disposal.
- 12. While some might follow the regulations and safety requirements to remove small amounts of asbestos, the safest way to manage its removal is to retain a licenced professional asbestos removalist equipped to protect you and your family from the dangers of asbestos dust and fibres.
- 13. Where asbestos fibres are friable (loose and not bonded into building materials), ONLY licenced friable asbestos removalists are allowed to remove it.
- 14. Professional removal of asbestos is affordable. You can't afford not to use a professional!
- 15. The cost of asbestos removal by a licenced professional is comparable to most licenced tradesmen including electricians, plumbers and tilers.
- 16. The cost of disposal at a lawful site is often included with the cost of removal by a licenced professional.
- 17. If you must work with any material that may contain asbestos or remove asbestos yourself, protect yourself and your family and follow the legal and safety requirements for the management of asbestos to minimise the release of dust or small particles from the asbestos materials.
- 18. There are a number of safety precautions you will need to take including wearing specific protective clothing, the correct mask or breathing apparatus and ensure you minimise dust and dispose of it legally.
- 19. Never use tools on asbestos materials as they will make asbestos fibres airborne including:
- a. Power tools such as electric drills, angle grinders, circular saws and electric sanders.
- b. Never use high pressure water blasters or compressed air.
- 20. Are you playing renovation roulette? Get to kNOw Asbestos this NOvember! Visit asbestosawareness.com.au Because it's not worth the risk!

Purpose

The purpose of this report is to inform Council of a service level agreement between Bourke Waste Advisory Committee (BWAC) partners in which Bourke Shire Council is a part of.

Background

Bourke Shire Council is a key partner on the BWAC. The BWAC was established to develop, implement, monitor and evaluate a new sustainable and viable waste management model for the Bourke and Enngonia Communities. The model is being implemented into locations in Bourke at the Alice Edwards Village and the Western End of the Bourke Township.

Discussion

Partners have taken a solution brokerage approach to the project, under the lead of Waste Aid an industry based charity, and bringing together relevant Aboriginal community organisations and government and non-government stakeholders. The scope of the project has six discrete but inter-related components:

- 1. Legacy clean-up of accumulated bulk waste, litter and illegal dumping
- 2. Development of viable infrastructure and waste service solutions
- 3. Development of appropriate community education and behaviour change programs
- 4. Community led stewardship program with engagement of Community Environmental Advisers for waste management
- 5. Service delivery agreement with Bourke Shire Council
- 6. Upgrade of the current Enngonia waste facility

Long-term goals of the BWAC also included:

- 7. Remediation of Asbestos contamination
- 8. Remediation of the old Bourke Tip site
- 9. Re-establishment of the kerbside recycling service to Bourke and commercial premises
- 10. Potential employment of an Aboriginal Liaison Officer by Bourke Shire Council.

At the September meeting of the Bourke Waste Advisory Committee, the Committee agreed to finalise the Service Level Agreement for Alice Edwards Village and the western precinct of the Bourke township. The agreement will provide management support services in order to maintain continuing and sustainable waste management arrangements for the above mentioned areas of the Bourke Township. Delivery of these services will continue to be monitored by BWAC.

Service Level Agreement

Bourke Shire Council: Provide baseline waste services for Alice Edwards Village and the Western precinct of Bourke

- 1. 1 x weekly bin collection (1 x bin per household)
- 2. 1 x weekly collection of metal bins AEV park (3 x bins AEV park)
- 3. Periodical bulk waste collections/clean up

4. Removal of marked vehicles for disposal (Bulk waste collection and car management is subject to continuing funding (see below) from Rural Fire Service)

Murdi Paaki Regional Enterprise (MPREC): Community Based Environmental Management

- 1. Litter Collection and small waste clean up
- 2. Bin maintenance
- 3. Skip trailer access, use and control
- 4. Retained vehicles to pad management

Rural Fire Service: Hazard reduction and community fire self-management

- On-going funding for Bourke Shire Council for bulk waste removal for hazard reduction (Bulk waste collection and car management is subject to continuing funding in Rural Fire Service budget)
- 2. Quarterly bin cleaning (When this assistance is requested either by MPREC or Bourke Shire Council)
- 3. Car Pad preparation
- 4. Cultural fire management and hazard reduction

Waste Aid: Community Infrastructure and Project Coordination

- 1. Project coordination and project management (BWAC Chair)
- 2. Community education materials
- 3. Supply of community infrastructure (1x new bins/household, 2x skips, 3x metal public bins)
- 4. Aboriginal Community Based Environmental Management (Community Environment Advisors, Community Based monitoring and Survey)
 (Continuing employment of Community Environment Advisors is subject to funding availability and recruitment process undertaken by panel formed from Nulla Nulla LALC, MPREC, Waste Aid and Bourke Shire Council)

Nulla Nulla LALC and Maranguka: Community landholder approvals, education and advice

- 1. Invitations, approvals and authority to work
- 2. In-community waste education
- 3. In-community event coordination
- 4. In-community support and assistance

Background:

Council had previously approved the attendance of the Mayor, Cr Andrew Lewis, Cr Cec Dorrington and I at the conference which was held at Rosehill Racecourse which I must say provided a very spacious venue for delegates and the sponsors of the Conference.

In addition to the conference itself all three representatives attended a meeting of the Western Division Councils on the Monday Evening whilst Council Lewis and I also attended the inaugural meeting of the Far Western Initiative Advisory Committee.

Current Situation:

There was a strong focus as you would expect on the current Local Government Reform process with the presentations of both Premier, the Hon. Mike Baird, MP and the Minister for Local Government the Hon Paul Toole, MP being almost entirely dedicated to the issue.

It was clear from both presentations that there was an agenda for significant change and it was indicated that all Councils in New South Wales would have a clear direction by Christmas 2015. The announcement of the IPART Assessments on Tuesday of last week certainly added some weight to that commitment with all Councils required to provide a response to the IPART determination within 30 days; this obviously excludes those Councils in the Far Western Initiative who were exempt from the "Fit for The Future Process".

In additional a Panel Session hosted by Ellen Fanning also heavily debated issues related to the reform process. Members of the Upper House Committee who undertook the Inquiry into Local Government formed the basis of the Panel and they were joined by Professor Percy Allen AM and Dr Joseph Drew, A research Fellow in Local Government at the UNE Centre for Local Government.

During the lunch break on the Tuesday the General Managers were invited to a working lunch and heard presentations from Donna Rygate the Chief Executive of Local Government New South Wales, Linda Bostock CEO of StateCover Mutual on proposed changes to the operations of StateCover as well as the CEO of Local Government Superannuation Peter Lambert who detailed options for Councils to ensure that they have sufficient funding available to meet the Commitments of the Defined Benefits Superannuation Scheme for which Councils are currently paying a catch up amount due to the income losses as a result of the Global Financial Crisis (GFC).

As Council representatives we had the opportunity to catch up with a number of the people we deal with on a regular basis but rarely meet in person including David Baird of Marsdens Lawyers who have provided us with advice on a number of issues as well as representatives from State Wide, StateCover and the Office of Local Government, including the opportunity to speak with the Acting Director of the Office of Local Government, Tim Hurst.

Financial Implications:

The costs for the attendance at the conference were met from existing budgetary provisions.

Background:

Councillors are aware of the proposal of CAPRA Pty Ltd to construct a small stock abattoir at Bourke.

On the 5th October 2015 the Department of Planning held a Planning Focus Meeting in relation to the proposal during which relevant Departments and regulatory authorities had the opportunity to discuss with the proponents their requirements in relation to the proposed development.

The Department of Planning have since invited all those bodies to detail these requirements so that the proponents are aware of what issues they will need to address in the Environmental Impact Statement (EIS) which is required to accompany any Development Application.

Council is required to provide details of issues that they would like to see addressed in the EIS.

Current Situation:

Council staff have raised the issue of disposal of all forms of waste from the proposed abattoir.

One of the options being considered was the disposal of the waste at the Bourke Waste Management Facility and to fully evaluate the ability of the facility to be able to handle the waste under current licensing conditions a relatively accurate estimate of the quantity and type of waste is required.

Depending on the volume of waste, alterations may be required to the way in which the current Waste Management Facility operates. The Waste Management Facility is currently not a licenced landfill as it does not exceed the 5000 tonne threshold governed by the POEO Act. If waste totals exceed the 5000 tonne threshold the landfill site will need to be licenced with the EPA this could trigger some significant changes including the possible installation of a weighbridge and the installation of additional monitoring facilities.

Council will need to ask the proponents to detail the volume of waste to be generated and the proposed method of disposal.

Financial Implications:

Depending on the amount of waste that will be generated and how it is to be disposed it may mean some significant alterations to the way in which the Bourke Waste Management Facility is licensed and operates. This may require some potential capital investment in relation to any new infrastructure and involve ongoing additional running costs. These will be contingent on the volume and type of waste generated.

Recommendation:

Council seek Clarification of the amount and type of waste to be generated and the proposed method of disposal.

Background:

The Minister for Local Government, the Hon. Paul Toole, MP established the Far West Initiative Advisory Committee (FWIAC). The role of the Advisory Committee is to provide advice on the development and implementation of the Far West Initiative.

The Minister also appointed the former Member for Murray Darling, John Williams to Chair the Committee.

The Far West Initiative, announced as part of the "Fit for the Future" package aims to deliver a new governance and service delivery model to apply across all levels of Government to secure better outcomes for local communities.

The initiative is being delivered by the Office of Local Government (OLG) and Department of Premier and Cabinet (DPC).

Current Situation:

The FWIAC is made up as follows:-

- Chair (John Williams)
- A representative of each of the eight (8) Councils in the region
- DPC Executive Director, Regional coordination
- OLG director, Innovation and Development
- A representative from the Commonwealth Government
- A representative of the non-Government service delivery sector
- A representative from the Murdi Paaki Regional Assembly

In addition to the above each of the General Managers was able to attend as observers/ advisers and other staff from both the OLG and DPC attended as they have behind the concept to date and will be providing the ongoing secretariat support to the Committee.

As the meeting was the inaugural meeting it was an opportunity to meet other delegates and recap the journey to date.

One of the issues to be determined was the best way to engage with all stakeholders with the various communities, noting the wide area covered by each of the Councils and the diverse range of groups involved.

The Minister has not put a timeframe on the establishment and implementation of the Far West Initiative (FWI) but has said it will take as long as is needed to get it right. In this context it should be noted that the Chairman's appointment is for a three (3) year period.

It was acknowledged that there will need to be meetings held in both Sydney and various locations within the proposed FWI region and in this regard it was determined that the meetings were alternate between a Sydney and rural venue. The next meeting will be held in Bourke on the 7th December 2015.

In general terms until something is decided the discussions and concepts tabled at the meetings should be kept confidential, however, this needs to be in the context of being able to be obtain feedback from all Councils and other stakeholders.

The next significant milestone will be the finalisation of a discussion paper which will the LOG and DPC feel suggest will:-

- Establish the evidence base for reform, drawing on preliminary consultation with Councils, State and Commonwealth agencies and non-Government organisations
- Analyse and seek feedback on options for improving Local Government financial sustainability and strategic capacity; and
- Identify how different options might provide a foundation for broader whole of Government governance and service delivery reform in the Far West

Financial Implications:

As delegates were in Sydney the only cost involved was the additional night's accommodation.

The broader implications from the establishment and implementation of the far West initiative can have a significant impact on both Council and the community.

Background:

Council has for some time been working with the Member for Barwon, Kevin Humphries to see a return of an air service to Bourke. Over the past two (2) years the Department of Premier and Cabinet (DPC) have done a considerable amount of work on the proposal involving consultation with a number of stakeholders, to ascertain potential usage.

The DPC had previously called for expressions of interest from operators for a service which would involve flights from Dubbo to Bourke and on to Walgett in a triangulation model with a number of Government agencies committing to the purchase of seats. The NSW Governments current and future travel demands between the three centres will provide a seat guarantee, supporting the service over the next four (4) years and assisting providing stability during the start-up phase.

Current Situation:

Following an evaluation of the proposal and the benefits to the communities, the Minister for Transport and Infrastructure the Hon. Andrew Constance, MP and the Minister for Regional Development, the Hon Barilaro, MP have issued a press release indicating that four (4) air operators will be invited to submit a proposal to provide the service linking Bourke Walgett and Dubbo.

In the press release Mr. Barliaro said:-

"Creating greater access between these towns will improve connectivity for business, create more jobs and provide Western NSW with the air services for access to important services such as health, education, business and recreation.

The tender process will commence next month and while the resumption of flights will be a commercial decision for the successful tenderer, which is expected to be awarded mid-2016.

Council has also lodged an application under the Regional Tourism Infrastructure Fund for the upgrade of the lighting and the runway at Bourke Airport and if successful will complement the re-introduction of the air service.

Financial Implications:

There will obviously be some costs associated with the additional travel generated at the terminal however; these costs can be off-set by the introduction of a landing fee.

The broader financial implications for the community are quite significant in terms of reduced travel time, increased accessibility for the tourist market, greater access to the eastern seaboard with the ability to connect with flights out of Dubbo to Sydney, Melbourne and Brisbane.

The reduced travel time will benefit many of the professionals who visit Bourke to provide services including health by allowing a greater level of efficiency and the same applies to the provision of services by Government agencies.

There is no significant financial implications for Council.



Report: 356/2015	Release of the IPART Assessment of NSW "Fit for the Future Proposals

Background:

All Councils in New South Wales were invited to submit a "Fit for the Future Proposal' to be assessed by IPART. The Proposals were to be submitted by the 30th June 2015.

The submission of a "Fit for the Future Proposal" was optional for those eight (8) councils in the Far Western Initiative and none of the eight Councils took the opportunity to submit a proposal but rather electing to devote their attention to the formation of the initiative.

IPART were to deliver their assessment to the State Government by 16th October 2015 which they apparently did.

Current Situation:

IPART assessed each of the proposals against the following criteria:-

- Scale and Capacity
- Financial Criteria
 - > Financial sustainability
 - Infrastructure and service management
 - Efficiency

The results were made public on 20th October with all Mayors being invited on the evening of the 19th October 2015 to participate in a webinar the next morning.

I have attached notes from that meeting which were compiled by the Staff of the Local Government Professionals (attachment 1) of which I am a member, also a "Report Card" issued by IPART (attachment 2).

The state Government has also launched a Stronger Communities Fund which proved an incentive to Councils to consider merging and details of this were announced during the webinar and are detailed in a fact sheet supplied by the Government and detailed in Attachment 3.

The Government has also provided a fact sheet detailing the next steps for Councils and this is also in a fact sheet reproduced as attachment 4.

Local Government New South Wales has provided an initial response to the determination by IPART and it is detailed in attachment 5

Clearly there is a strong push for mergers to take place and no doubt the next thirty days will result in some significant decisions having to be made.

This is the Minutes of the Ordinary Meeting of Bourke Shire Council held on Monday, 26th October 2015 in the Council Chambers at 9.00am.

Financial Implications:

There are no financial implications for Bourke Shire Council at this stage. However, Council should be mindful of the funding incentives being provided.

Premier Mike Baird

Good morning I am hoping that all the Mayors on the line can hear me and thank you for coming together today.

I also have Dr Peter Boxall from IPART and the Minister here and we wanted to run through effectively the release of the IPART report today.

This process we have done together – genuinely done it together, we have worked side by side with local government every step of the way.

I think it's fair to say that it has come to the point that we now have to make some final decisions and I have to say that we are clearly disappointed to date in terms of the responses from councils because what we can see are significant community benefits in undertaking mergers and that is what we are interested in i.e. what is the community benefit and I will let Dr Peter Boxall take you through the macros. But in simple terms there is hundreds of millions in benefits and in Sydney metro area alone (up to \$2 billion alone) in community benefit/windfall that can come to councils in next 20 years if merger proposals are undertaken.

A number of councils have undertaken this analysis and can see benefits but a large number have decided to not pursue mergers. We said we would come aqnd consult with councils and that is what we are doing.

We are asking councils to respond in 30 days to the IPART report. Our hope is that merger proposal come to us to unlock these benefits so that they can be delivered in terms of improvements in additional services, infrastructure, and downward pressure of rates or combination of all three.

That is really the only thing we are focused on and we are handing it across to you and we are asking for genuine consideration and response from councils and one that puts the rate payers first in terms of significant benefits. I want to congratulate the work that IPART has done.

Dr Peter Boxall IPART

This has been an independent very rigorous process which has drawn on IPART's own expertise in local government as well as drawing upon an expert in local government John Comrie from SA.

The analysis is based on information provided by councils themselves as well as input from community and other data available

The savings found have been based upon councils own proposals. We have assessed one third of the councils as fit –i.e. 52 proposals as fit which includes the 4 merger proposals (Randwick and Waverley, Auburn, Burwood and Canada Bay, Young and Boorowa, Cootamundra and Harden).

Shaping the future of local government

Other fit councils: 7 Metro, 32 Non Metro, 9 Rural.

Of the ones that are unfit in the metropolitan area it is because they did not pass the scale and capacity criteria – they were given the merger option in the Independent Panels report and they decided to propose standalone option.

In the non-metropolitan area – some not satisfying scale and capacity but others did not satisfy the financial criteria 2-4.

We did assess the City of Sydney – as not being fit against the global city criteria In the event that the government did not accept the global cities criteria, we have noted that if City of Sydney was assessed against the standalone criteria, they would have been regarded as fit.

There were 3 councils in outer metropolitan area as assessed as not being fit: Blacktown, Campbelltown, and Hawkesbury – as while they satisfied the scale and capacity criteria they did not satisfy the financial criteria 2-4.

In assessing the financial criteria we looked at the overall assessment of 2-4.

Rural – there were 20 proposals, 9 assessed as fit and 11 assessed as not fit. The 9 that were assessed as fit against the rural council model – if the government do not decide to adopt rural council model then those councils most likely will not be fit against regular models.

Other areas to mention: Central Coast – Newcastle, Lake Macquarie, Gosford and Wyong were assessed as not fit and not satisfying scale and capacity criteria. They were assessed against the merger option and their standalone proposals were not deemed as good as the merger option.

Minister Paul Toole

The release the report is a milestone in the reform of local government in this state. Councils asked for the report to be released and I am pleased we have done this just after a few days of receiving it.

I would like to thank the councils who have used the process to improve services, infrastructure and benefits for councils. In particular I would like to thank councils who have put options for structural change. I am disappointed that there were not more of you and I am hoping this will change today.

As you know, we received the IPART report on Friday and we have had time to review it and I can tell you it paints a sobering picture for local government and more positively, it demonstrates the benefits of change for communities.

The IPART report finds reducing waste and red tape through mergers could free up \$2 billion over the next 20 years for NSW rate payers. As you know, we have been consulting with the local government sector including the Mayors and our key industry groups as well as the community for four years.

This process has told us that the current system of local government is not working as well as it should be – we know now it is worse, we know that the system is broken.

Today I'll be calling on councils to do the right thing by your community, and this might mean merging with neighbouring councils.

Today I will be strongly encouraging councils to particulate in the final consultation process over the next 30 days and provide their input into the local government reform policy.

You will be receiving a letter from the Secretary Department of Premier and Cabinet that will outline what you need to do in next 30 days. We are serious about ensuring councils across NSW recognise what they need to do in order to be better able to deliver the services and infrastructure their community's needs.

The government is also announcing today the establishment of a Stronger Communities Fund – to provide participating councils a head start on community infrastructure projects i.e. sporting fields, libraries or parks. We will also be funding the cost of merging – this funding will be available for council mergers supported by the government and discussed with government prior to 18 November. This is a significant funding package. In addition to covering costs of mergers the stronger community fund will offer up to \$15 million to councils for community infrastructure projects.

IPART has found that merged councils can achieve more benefits that non merging councils could achieve by only increasing rates. IPART also found that while all councils submitting merger proposals were deemed to be fit on the basis of the benefits the merged council would achieve, these benefits are even greater if neighbouring councils also merged with them.

This is the time to do what your council needs to do to become fit and to also work with the state government's generous offer of support to deliver services and infrastructure for your communities. We need to have strong local councils that can deliver service and infrastructure.

We know mergers will deliver savings and will deliver better services, more infrastructure, or lower rates. I look forward to working with you in the reform of local government.

Question and Answers

Q. Eurobodalla to Minister: When will the process be finalised? What is your time frame?

A. We will release the IPART report ASAP. Councils will have 30 days from today (until 18 November) to put forward their voluntary merger proposals, during this time the government will also be formulating a response to the IPART report. Our commitment is that we want to make all councils will know where they stand by the end of the year.

Q. Murray Shire to Minister: Is the merger money still on the table?

A. The money is still on the table as part of the stronger communities fund which will provide councils who do a voluntary merger to receive a head start. Each new council will be eligible for up to \$15 million for community infrastructure projects i.e. sporting fields, libraries, parks. Regional councils will receive \$5 million, metropolitan Sydney councils will receive \$10 million and any new council formed by merging with 3 or more councils will receive an extra \$5 million. Funding of up to \$5 million for regional - \$10 million for metropolitan areas is available for each new council to ensure rate payers do not pay for the upfront costs of that merger — this is available for next 30 days. This is your final chance to receive this money.

Q. To the Premier: When will the community get a chance to have their say on mergers?

A. Baird said: The community has had a long say on mergers. This process has been running for many years and part of this has been the IPART process. Significant consultation has been underway. Local

councils now have everything - they have submissions, IPART report, business cases (benefits to mergers). Now they have to act —we are now at end of the road and decisions need to be made. Our hope is that councils now have the opportunity with receiving this report to make their decisions.

Q. Forbes to Minister: When is the report available?

A. 12 noon today. A letter will be sent out to all Mayors with clear directions and instructions on what is required from councils over the next 30 days and what funding packages are available for councils.

Q. Goulburn to Minister: Does the IPART recommend specific mergers?

A. The report shows significant benefits and savings which can be made if mergers are to take place. Savings can be passed back onto communities for services, infrastructure or stabilising rates. I might ask Dr Peter Boxall to comment on this.

A. Dr Peter Boxall IPART: The report does not recommend mergers. We have assessed all proposals as being fit or unfit against the criteria as outlined in September 2014 by the government. We used the Independent Panel's preferred option as a starting point.

Q. Kiama to Minister: Will the pilot JOs continue?

A. We are committed to pilot the JOs. We have 5 regional pilots operating across the state. We have seen excellent work in regional collaboration. Will use the pilots to put into place another 2 JOs in regional communities.

- Q. Strathfield to Minister: Will we be able to get a time extension on the deadline? 30 days is insufficient for our communities.
- A. No there will be no extensions. The process has been going on for 4 ½ years.
- Q. Strathfield to Minister: Should we still decide not to put in a merger proposal will you force councils to merge?
- A. All councils need to have a good look at themselves over next 30 days. I hope they do see the benefits and savings back into your communities.
- Q. Corowa to Minster: Will councils who cannot get cooperation from neighbours to merge do they still get funding?
- A. Not Answered Funding is there for voluntary mergers. I can only encourage you to sit down with neighbouring council and talk over the benefits.

- Q. Wingecarribee to Minister: If there are significant amalgamations in regional areas will the government consider deferring the JO to allow mergers to be formed and consolidation?
- A. No it is important for JOs to continue to run it is important for regional collaboration. Those boundaries will be considered after we receive the final submissions at 18 November.
- Q. Burwood to Premier: What do those councils who submitted a voluntary proposal need to do? Do you need to resubmit the proposal?
- A. No firstly we appreciate those who have done this and shown they want to deliver better service and have extra financial capacity for their community thank you. There could be preferences for additional partners and that could be considered. The question is there an opportunity to do more?
- Q. Coffs Harbour to Minister: The original FFF package was \$600m savings on borrowings assuming there is about \$200m left, how much new money is on table, including the Stronger Communities Fund?
- A. A record \$1billion was provided to support councils to make changes in the interest of their communities. The state financing authority is ready to go to support fit councils with reduced interest loans.
- Q. Forbes to Dr Peter Boxall: What is the process if council disagrees with the IPART determination?
- A. We have made an assessment on fit or unfit, and we are not planning to re- opening that. We will explain our reasons in more detail for our assessment in the event that you contact IPART. In the report, there is a 1 to 2 pages of reasons for each council.
- Q. Rockdale to Peter Boxall: Did IPART consider the metropolitan JO idea as part of their assessment?
- A. In the case where councils put JO proposals in we did review this and were mindful that some of the panel's recommendations includes JOs and we did take this into account for our assessment.
- Q. Parkes to Premier: Does support funding package apply to new councils only? Will councils deemed fit also be able to access funds?
- A. All councils deemed to be fit can access the state financing authority that will allow councils to have borrowings and have cheaper loans which can be then used for infrastructure projects. The opportunity will still be there for councils to make significant savings through borrowings set up through authority.

Q. United Services Union to Minister: Will the Minister confirm that local government will remain in the NSW industrial system under the Local Government State Award?

A. That is correct. I have made this commitment in the past and that councils will stay under the Award and we know this includes a 3 year employment protection. We believe mergers will support staff development and opportunities for promotions.

Q. Harden to Minister: Will councils who submitted merger proposals through the FFF process be asked to look at broadening the merger proposal with other surrounding councils?

A. Councils should indicate which councils do support the proposal and which ones don't. If there are neighbouring councils who do not want to have discussions, I am sure that these submissions will be put forward by those councils.

Q. Fairfield to Premier: Is there any proposed change of date for the elections?

A. No we are working towards the date of the elections to be held in September 2016. I would like to say that this is now time for councils to determine the significant benefits that can be delivered for your communities. Don't hold back regarding services, infrastructure and downward pressure on rates. It is time now to deliver on this. We have done everything and our actions are to help you on this. Councils need to take this opportunity and I look forward to your responses.

IPART assessment of NSW council Fit for the Future proposals

The Independent Pricing and Regulatory Tribunal (IPART) has recently provided the NSW Government with its report on the assessment of 139 Fit for the Future council proposals (received from 144 councils).

This report card provides a snapshot of what IPART found.

IPART assessed the proposals against the following criteria:

- · Scale and capacity
- · Financial criteria
 - Financial sustainability
 - Infrastructure and service management
 - Efficiency

The IPART report clearly shows that the system of local government in NSW is broken.

REPORT CARD - Key Findings

Merger benefits - up to \$2 billion

IPART conducted additional analysis on business cases submitted by councils and estimate between \$1.8 billion to \$2.0 billion in NPV benefits could be realised over 20 years if mergers were to occur in Sydney. IPART's estimate includes Government funding for implementation.

Ernst & Young also estimates these mergers could yield substantial financial gains with \$1.3 billion in NPV benefits over 20 years.

Mergers bring other benefits

Other merger benefits include:

- · More effective and efficient service delivery.
- · Improved delivery of major infrastructure.
- More integrated strategic planning and policy development.
- Enhanced economic growth.
- · More effective partnering with government.
- · Stronger advocacy for local communities.

Most councils did not provide merge proposals

IPART received 139 proposals from 144 councils which included only four Merger Proposals (3% of total). The independent panel recommended merges as the preferred option for 41% of councils.

Many councils prepared business cases that showed mergers would benefit the community but chose not to proceed.

Councils prefered rate rises to merging

Many councils proposed rate increases to improve financial performance. Some 32 councils proposed a rate rise to get fit with 15 councils proposing rises above 30%.

IPART found that structural changes could achieve similar or larger improvements to council's income and reduce the need for rate increases, limiting the impact of higher rates on the community.

Almost two thirds of councils are not fit

IPART assessed 52 proposals as being fit for the future, which represents just 37% of the proposals received.

REPORT CARD - Metro Key Findings

IPART assessment

IPART received 38 proposals from metropolitan councils, including two merger proposals and 36 Council Improvement Proposals (i.e. stand alone).

IPART assessed 9 proposals as fit and 29 proposals as not fit in Metropolitan Sydney.

Merger proposals

Two merger proposals from metropolitan councils were received. These were assessed as fit because the mergers would deliver substantial benefits to their local communities when compared to the councils standing alone.

IPART still observed greater benefits would be realised from including neighbouring councils in these mergers.

Outer Metro Councils

Six of the seven councils assessed by IPART as fit are in Outer Metropolitan Sydney. These councils were assessed as fit because their proposals met the financial criteria overall, and IPART analysis did not identify a merger alternative that was better than remaining a stand-alone council.

Inner Metro councils

With the exception of Bankstown, all Inner Metropolitan Sydney councils that submitted a stand-alone proposal were assessed not fit, as they did not meet the scale and capacity criterion.

This means the assessment demonstrated the community would benefit from a merger.

Merger benefits

IPART's analysis of councils' own submissions suggests up to \$2.0 billion in NPV benefits could be realised over 20 years if the Metropolitan Sydney mergers preferred by the Independent Local Government Review Panel occurred.

Council business cases

A number of councils commissioned business cases of merger options including variations on structural changes identified by the Independent Panel on Local Government.

Some of these showed there could be substantial benefits from merging. However, despite these potential gains, most Metropolitan Sydney councils did not submit a Merger Proposal.

Financial criteria

IPART assessed three councils as not fit because they did not demonstrate they met financial criteria overall, however, IPART identified strategies that should enable them to become fit.

City of Sydney

IPART noted that the City of Sydney received the highest number of public submissions of any council, with the majority of submissions supporting the council remaining a standalone council.

IPART however assessed the City of Sydney as not fit as it does not meet scale and capacity criteria when compared to "Global City Council" attributes as identified by the Independent Panel on Local Government.

Joint Regional Authority

Hunter's Hill, Lane Cove and Ryde Councils submitted a proposal to share some services and centralise planning indicating benefits of \$0.5m over five years or \$3.4m if Mosman North Sydney and Willoughby were included. In contrast, IPART estimated a merger would save \$280m over 20 years and therefore assessed the proposal as not fit.

REPORT CARD - Regional Key Findings

Merging delivers benefits

IPART's report shows mergers deliver significant benefits to participating councils, including improving a council's scale and capacity, and financial outlook.

All regional mergers assessed by IPART were found fit.

All regional councils that had been provided a recommended merger option from the Independent Panel on Local Government but opted to stand alone were unable to demonstrate that this was the better option for their community.

58 councils not fit

101 regional proposals were received (including 20 rural council proposals) covering 104 councils.

Only 43 proposals assessed as fit for the future.

Only two merger proposals were received – Young Shire Council/Boorowa Council and Cootamundra Shire Council/ Harden Shire Council. Both mergers were assessed as fit for the future but IPART noted that a four way merger would deliver larger gains to the community.

Scale and capacity can be improved

There were 34 regional councils assessed as having insufficient scale and capacity. In a number of cases these councils have declining or static populations, with population forecasts below 10,000 by 2031.

A population of this size is likely to affect a councils efficiency and strategic capacity to meet the future needs of its community.

Mixed performance

- 24 councils were unable to meet IPART's financial benchmarks.
- 43 councils did not reach the benchmark for scale and capacity.
- Poor financial performance was generally a result of ongoing operating deficits through to 2019-20.

Opportunity to be fit


27 of our regional councils that were found not fit had a viable merger proposal that they did not act on.

There is now an opportunity for these councils to reconsider the benefits of merging.

Rural Councils

IPART assessed 11 of the 20 rural council proposals as not fit. These councils were either unable to meet the lower benchmarks or a merge offered greater gains.

There is a risk councils have proposed future SVs to improve their financial performance, and may not have fully considered whether alternative structures for the local government area, such as a merger, may be a better outcome." "Structural changes could achieve similar or larger improvements to a council's general income and reduce the need for, and size of, potential SV increases, which could limit the impact of higher rates on the community. This was apparent during the assessment process." (p37)

Councils should consider voluntary mergers

The final consultation opportunity for councils

After four years of partnership, the NSW Government is giving councils a final 30-day consultation opportunity to inform the Government's position on local government reform and respond to the IPART findings

20 October 2015

Councils receive briefing from the Premier and Minister on the findings of the IPART assessment of council Fit for the Future proposals.

21 October 2015

Councils receive an invitation from the Secretary of the Department of Premier and Cabinet to provide feedback on the IPART report and indicate their merger preferences.

By 18 November

Councils are encouraged to review IPART's assessment of their Fit for the Future submission and respond.

The assessment is available on the IPART website www.ipart.nsw.gov.au.

Councils should provide feedback using the online portal on the Department of Premier and Cabinet's website, which will be available shortly.

For councils that are assessed as being not fit due to scale and capacity, or who neighbour a council that was not fit due to scale and capacity, the Government would also like to know, through the online portal, the merger preferences of these councils.

Funding is available for mergers agreed to by councils and the NSW Government.

By end 2015

The Government will consider responses from councils, decide on next steps and inform councils and the community.

Communities now critical to local government

Local councils and their communities have been given one last chance to determine their own future after IPART ruled almost two-thirds do not meet the State Government's Fit for the Future criteria, Local Government NSW (LGNSW) said today.

LGNSW President Cr Keith Rhoades, speaking after the release of the IPART report, said it has never been more critical for councils to go back to their communities to work out their next steps.

"IPART says the reason the majority of councils were found unfit is because they opposed the Government's proposed merger option and submitted a stand-alone proposal," CIr Rhoades said. "This is what we expected."

"Only 57 of the State's 152 councils were found fit: seven metropolitan councils, 32 non-metropolitan councils, nine rural councils (assessed against different criteria) and four groups of councils who proposed voluntary mergers.

"The City of Sydney was found unfit solely because it rejected the proposed 'global city' Mega Council amalgamation, while three councils not even slated to merge – Blacktown, Campbelltown, and Hawkesbury - were found unfit on financial criteria."

Clr Rhoades said the Government had today announced a "Stronger Communities" fund, for council investment in community infrastructure such as parks, libraries and swimming pools, while reiterating that funding would be available for the upfront costs of amalgamation.

"I'm pleased the Government has responded to concerns over the potential impacts of amalgamations on the community," he said.

"We don't have answers to legitimate questions on how much new money is on the table, rather than repackaged money previously announced.

"We know from experience elsewhere that amalgamations will cost the community significantly more than the \$10 million available to voluntarily amalgamating metropolitan councils, and the \$5 million to voluntarily amalgamating regional councils.

"And we note that the Stronger Communities fund announced today appears to be only available to councils who submit agreed amalgamation plans before November 18, not to others including those already found fit.

"The Minister has made it very clear that this is a time-limited carrot. Those who don't agree to merge seem destined to be forced to do so - without financial support."

Clr Rhoades said the Government was also expected to launch a new phase in its \$1 million-plus Saatchi and Saatchi advertising campaign promoting the need for fewer councils.

"The research shows the community trust their councils far more than they do other spheres of Government," he said.

"Some 75% believe Local Government is best able to make decisions about their local area, compared to 26% who think the State Government is best placed and 2% who believe the Federal Government does it best.

"That's why it is so important that councils get back out there and ensure that their residents and ratepayers clearly understand what is on offer and what is at stake.

"We <u>all</u> want stronger communities, and LGNSW has said all along that this issue must be one for the residents and ratepayers.

"I'd urge councils to speak directly to their residents and ratepayers about today's developments and then act accordingly."

IPART's classification of NSW councils as fit or unfit delivered no real surprises to the sector today. The report and subsequent Government response has fulfilled sector predictions.

Councils worked hard to meet the Government's benchmarks, only to be found unfit for reflecting community feedback and seeking to maintain their independence.

While the Government announcement has answered some questions, more remain.

WHAT WE'VE LEARNED

- The majority of NSW councils were found "unfit" because they did not meet the Government's criteria. This is as expected.
- Just 57 of the State's 152 councils were found to be "fit". Of these, seven were metropolitan councils, 32 were non-metropolitan, nine were rural councils assessed against a different model, while the remaining nine were those involved in voluntary merger proposals.
- IPART confirmed the primary reason NSW councils were found "unfit" is because they
 opposed the Government's proposed merger option and submitted a stand-alone proposal.
 This was considered to mean that they did not have "scale and capacity".
- Three metropolitan councils not slated to merge were found unfit because they did not meet financial criteria. These councils were identified as Blacktown (the state's largest council), Campbelltown and Hawkesbury.
- Councils found to be unfit have been granted a period of 30 days to consult with their communities and submit their preferred amalgamation partner(s). No extensions will be granted, and IPART will explain but not revisit its fit/unfit finding.
- Control of the process has been escalated to the Department of Premier and Cabinet.
- The Government is offering a funding package it has dubbed "Stronger Communities". The
 package will provide funding for community infrastructure, but is only available to councils who
 submit an acceptable merger proposal by November 18, not to those already fit.
- This funding is set at \$5 million for merged regional councils and \$10 million for merged metropolitan councils. An additional \$5 million is available for new councils formed by three or more municipalities.
- The Government has reiterated funding support to contribute towards the upfront cost of amalgamation. Some \$5 million will be made available to each merged regional council and \$10 million for each merged metropolitan council – but only if approved mergers are submitted by the November 18 cut-off.
- Councils should "know where they stand" by the end of the year.

WHAT WE DON'T KNOW

- Is the "new" fund just the old, previously announced \$1 billion funding package (\$600 million of which is potential savings on interest, via cheaper loans from Treasury Corp)?
- What additional support is available for rural councils, beyond the Innovation Fund allocation?
- What happens after November 18? What will happen for councils who do submit a merger proposal acceptable to the Government – or who are willing to merge but rejected by their neighbours?
- Will the Government force the amalgamation of financially sustainable councils with community support?
- · By which process?

Background

The Division of Local Government released guidelines on the preparation of QBRS to Council in December 2010 with mandatory reporting in line with the guidelines commencing in July 2011.

The QBRS must show, by reference to the estimated income and expenditure that is set out in the operational plan adopted by Council for the relevant year, a revised estimate of income and expenditure for that year.

The guidelines also require the budget review statement to include a report by the responsible accounting officer as to whether or not they consider the statement indicates Council to be in a satisfactory financial position (with regard to its original budget) and if not, to include recommendations for remedial action.

Issues

- The QBRS must be prepared by the Responsible Accounting Officer and presented to Council within two months of the end of the quarter.
- The minimum format of the QBRS is governed by the Division of Local Government's Guidelines in December 2010.

Discussion

The QBRS has been prepared for the September 2015 review period and is presented to Council for consideration.

This review has been undertaken in consultation with the General Manager, Managers and other officers where applicable.

Council adopted a \$513,576 cash based surplus budget as part of the 2015/16 Operational Plan at the 25th May 2015 Council Meeting.

Overall Financial Position

The revised consolidated budget result following the September QBRS is estimated to be a surplus of \$566,954 an increase of \$53,378.

This report is to provide Councillors with a preliminary review of to the Financials Statement for 2014/2015.

Background

The Local Government Act 1993, Section 49 (1) stipulates that Council must present its audited Financial Reports, together with the auditors reports to a meeting of Council. The final report will be completed at the November Ordinary Meeting of Council, by Council's Auditors.

Report

Council's operating result was a surplus of \$3.668 million as compared with a \$1.32 million deficit in the previous year. This total is an overall increase over the previous year of \$4.988.

Financial Position as at 30th June 2014

Unrestricted Current Ratio

The unrestricted current ratio is an indicator that Council is able to pay its debt as and when they fall due. Council has marginally increased the unrestricted current ratio this financial year. The benchmark for this ratio is a minimum of 1.5:1.

Available Working Capital

These are funds available to Council to meet unforeseen and unbudgeted expenditure, and exclude any funds in reserve.

Available working funds in 2014/15 increased by \$1.388 million taking the 30/06/2015 figure to \$3,064 million compared to \$4,676 million as at 30/06/14.

Councils Auditors have indicated the Available Working Capital to be adequate after taking into consideration the nature and level of internally restricted assets (reserves) that have been set aside.

Debt Service Cover Ratio

This is a ratio that measures the availability of operating cash to service debt including interest, principal and lease payments. The benchmark for this ratio is a minimum of 2:1.

For 2015, the ratio indicated that operating results before capital, interest and depreciation covered payments required to service debt by a factor of 5.30:1

Cash Assets as at 30th June 2014

Cash and Investments

This figure includes funds held in internal and external reserves across all of the Council's functions along with any unspent specific purpose grants and contributions.

The total cash and investments figure increased by \$1.378 during 2014/15; taking the figure of \$10.252 million as at 30th June 2014 to \$11.630 million as at 30th June 2015.

Externally restricted cash and investments total \$3.983 million, internally restricted cash and investments total \$1.114 million, and unrestricted cash and investments total \$6.533 million, which is available to provide liquidity for day to day operations.

Receivables as at 30th June 2015

Rates and Annual Charges

Council's net Rates and Annual Charges amounted to \$3.439 million and represented 19% of Council's overall revenue for 2013/14.

Outstanding Rates and Annual Charges

The Rates and annual charges outstanding percentage has increased in 2014/2015 from 11% to 14.75%. This is due to the amount of land that the owners have effectively walked away from and will be subject to a sale for unpaid Rates. Provision is made annually to account for this amount.

Payables as at 30th June 2015

Employee Leave Entitlements

Employee Leave Entitlements (ELE) are the leave entitlements which were accrued as at the 30th June 2015, and equate to \$2,712 million.

Council had a cash reserve of \$594,000, funding the liability at 22%.

Council's Auditors have indicated that the Office of Local Government requires Council to fund ELE at a minimum of 20%.

<u>Other</u>

Building and Infrastructure Renewal

The Building and Infrastructure renewal ratio is an indicator of the proportion of depreciation which is being funded by expenditure on new assets. A ratio greater than 100% indicates that Council is spending more on asset renewal than the depreciation charge for the year. Councils Asset Renewal was 158.74%.

Conclusion

The Unrestricted Current Ratio has marginally increased over the past year. The Unrestricted Current Ratio is a financial indicator and represents Council's ability to meet its debts and obligations as they fall due. The available Working Capital position was also maintained at an acceptable level.

Council continues to maintain a relatively low level of debt and is in a sound financial position as reflected in our Auditor's reports and demonstrated by the financial performance indicators.

Council will need to continue to closely monitor the budget during the current and future years to ensure that the positive result continues to ensure the ongoing consolidation of the Councils financial position.

Bourke Laundry Service has recently been awarding a leading practice grant from Dept Social Services to assist our organisation in adapting to the National Disability Insurance Scheme which may impact negatively on our future funding. This funding was used to purchase 32 Richard Street (formerly Elders) in Bourke to provide us with security of tenure for our operations & give us a much higher profile in the community.

On purchase it was discovered there is no adequate mains supply of filtered water to the premises. It is my understanding Council has responsibility to provide this service & metering from the laneway between Oxley & Mertin Street – the boundary of the property is the external wall of the "shed" component of the building. What I am hoping Council can also do for us, is to extend this water connection through the "shed" component of the building (which will require cutting through poor quality cement slab) & install the meter in the back yard with access from Oxley Street. This would mean ease of access for meter readings & more importantly for Bourke Laundry, reduce our substantial plumbing costs associated with relocating the service.

The relocation of our service in the most cost efficient way, helps secure future employment for people with disability residing in the Bourke Shire; By purchasing and occupying such a highly visible premises we are vastly improving the vista of Bourke's CBD; the continuation of Bourke Laundry helps underpin future economic development in Bourke (such as the proposed abattoir & tourism) by providing a commercial laundry service

Council staff has recently erected tables for the park at Enngonia and once the canopies are erected over the seats and tables they will provide an ideal stopover point for visitors passing through town and another facility for those utilising the park area.

Monday's Council meeting saw the election take place for the office of Mayor and Deputy Mayor for 2015/2016. The Mayor, Cr Andrew Lewis was re-elected unopposed as was the Deputy Mayor, Cr Barry Hollman. This is Councillor Lewis's eighth consecutive term as Mayor whilst it will be fourth consecutive term for Councillor Hollman.

Representatives of RaRMS addressed Council during Monday's Meeting regarding their plans to provide medical services to Bourke over the duration of their contracted period. RaRMS already have already recruited an additional permanent doctor for Bourke and are confident that they will have a full complement of doctors available prior to the changeover on the 28th November 2015.

RaRMS have a presence in a number of towns already including Gilgandra, Tenterfield, Warren, Warialda and Bingara and with the addition of the six (6) towns that they will now service following the recent tender announcement RaRMS will have a significant foot print in rural New South Wales

Council reviewed its membership of its standing committees, internal Committees and Delegates to other organisations at Monday's meeting and there were no changes to the existing appointments.

Council will continue to meet on the 4^{th} Monday of each Month at 9.00am following a resolution passed at Monday's meeting. The meeting in January however, will be held on the 3^{rd} Monday in January to allow Councillors the opportunity to select the Australia Day Award Recipients. The 4^{th} Monday in March is Easter Monday and the 4^{th} Monday in April is ANZAC day so each of those meetings will also be held on the 3^{rd} Monday.

As part of their presentation last week the New South Wales Grants Commission tabled a map of New South Wales which detailed those Local Government areas that had experienced a population decline over the period 2001-2014. The map shows, that with a few exceptions, those areas west of the Newell Highway had generally experienced a decline.

During that time New South Wales has seen an overall population growth of 14.3% or 943,255 people. This is a clear demonstration of the population drift to the eastern seaboard of the state. The ongoing population increases along the eastern seaboard is placing considerable pressure on the infrastructure in those areas while there is existing capacity in the rural and regional centres that can readily cope with an increase in population and all that is required is sustainable employment.

The cost to provide the infrastructure to cater for the increase is enormous and the relocation of some industries to rural NSW would have beneficial impacts for all parties.

There needs to be a return to an active policy of decentralisation and if adopted is will assist in arresting the decline of Rural New South Wales.

The next Meeting of Barwon Darling Water is scheduled to be held on the 7th October 2015 at the Walgett Sporting Club and will commence at 10.00 am.

Together with the Deputy Mayor, Cr Barry Hollman, Cr's Cec Dorrington, Jack Bennett and Victor Bartley and I represented Council at the Police Remembrance Service on Tuesday this week. The service was held at Holy Innocents Anglican Church in Bourke with the Service being conducted by Police Chaplain, Graeme Yeager who was assisted by the Bishop for the Diocese of Wilcannia Forbes the Most Reverend Columba Macbeth-Green.

The service remembers those Police Officers who have been killed on duty and members of the Police Force who have died in the past twelve months.

The first stages of this masterplan are the installation of a water slash park for the little kids and the re-development of the small pool into program pool which will enable that pool to be put to a greater range of uses. A new filtration system to specifically cater for these two (2) facilities would be required to be installed in accordance with current requirements.

Bourke Shire Council commissioned a report from the New South Wales Department of Public Works in relation to the upgrade the bores within the Shire that service the villages. There has been a strong commitment from the current State Government to provide better water supplies across the state and in anticipation of additional grant funding possibly becoming available a number of "shovel ready" projects will be developed. Council is very conscious of the needs of the village communities and a reliable water supply is critical.

Councillor's Auditors Hill Roger Spencer Steer from Sydney have almost completed the audit of Council's Annual Financial Statements for 2014/2015. They will then provide a report to Council which needs to be included with the Financial Statements so that they can be lodged by the end of October as required.

Council is currently calling for tenders for the construction of three (3) bridges which, when complete, will mean that all timber bridges within the Shire have been replaced and Bourke Shire Council would be one of the few rural Council's that have been able to achieve this milestone. The bridges to be replaced are the Len Mallon Bridge near Enngonia, the Cuttaburra Bridge No. 2 and Whiskey Creek Bridge on the West Culgoa Road.

The abattoir will create 200 jobs when fully operational. Congratulations to the Bourke and District garden Club on the conduct of yet another successful Rose and Spring Collection Show on the weekend. When you drive around Bourke there are some magnificent examples of roses and they certainly add a lot of colour to the gardens and streetscape.

With the hot weather now upon us there is an increased risk of fire so all residents are asked to particularly cautious when undertaking activities that could lead to fire and this include the slashing of dry areas and the use of power tools in the open. If you need to undertake such work ensure that you have an adequate firefighting resources available.

While members of the Local Rural Fire Service are well equipped to handle emergency situations many such situations could be avoided if people took a little more care and properly prepared.

With conditions becoming more conducive to the spread of fire, people need to be extremely careful when using fire.

In times of total fire bans it is critical that the directions relating to these are obeyed. These include:-

- Anybody wishing to light a fire on their property during the Bush Fire Danger Period will require a permit from their brigade permit officer or Fire Control Centre.
- Even with a permit you need to check whether a Total Fire Ban is in place before lighting any fires.
- Have a Bush Fire Survival Plan, so all members of the household know what to do on days of increased fire danger, and if their home is threatened by fire.
- Residents should also continue with their hazard reduction activities.
- Residents also need to ask whether they need a Bush Fire Hazard Reduction Certificate.
- Never leave a fire unattended and if a fire does escape, it is essential to call Triple Zero (000) immediately so that emergency services can respond accordingly and minimise the damage.

We have all seen the devastation that bushfires can bring to a community, so you are strongly urged to contact your local brigades and use their expertise to assist in carrying out safe hazard reductions.

The much anticipated release of the IPART assessment of the New South Wales Council Fit for the Future Proposals occurred on Tuesday with all Mayors invited to a "webinar" prior to the public release of the document.

IPART assessed the proposals against the following criteria:-

- Scale and Capacity
- Financial Criteria
 - Financial sustainability
 - o Infrastructure and service management
 - Efficiency

IPART received 38 proposals from metropolitan Councils and of those proposals (9) were deemed as fit and the remaining 29 deemed to be unfit. In the rural areas 101 proposals were received including 20 rural Council proposals and of these only 43 proposals were assessed as fit for the future.

The Councils who were involved in the "Fit for the Future" process will now each receive a letter from the Department of Premier and Cabinet detailing the courses of action open to them and they have 30 days to respond.

Bourke Shire Council has been earmarked for membership of the Far Western Initiative and as a result did not participate in the "Fit for the Future" process and will be working with the Far Western Initiative Advisory Committee to develop a new model for this part of the state.

The Inquiry will look at both the positive and negative impacts of the Murray-Darling Basin Plan and associated Commonwealth programs on regional communities.

Bourke Shire Council has for a number of years used every opportunity to highlight the detrimental economic impact on Bourke Shire as a result of the Murray- Darling Basin Plan and will be utilising its time before the senate inquiry to again highlight the impact.

Bourke Shire Council has been advised that they are a finalist in the 2015 Local Government New South Wales Excellence in the Environment Awards for the Community Sharps Management. Bourke Shire Council coordinated a regional initiative involving the installation of sharps disposal facilities in Bourke, the clean-up of contaminated areas as well as increasing the level of training locally. Council has been concerned at the potential hazards being created by the indiscriminate disposal of sharps and this concern developed into a regional leadership role.

The presentations will take place at Darling Harbour on the 1st December 2015.




